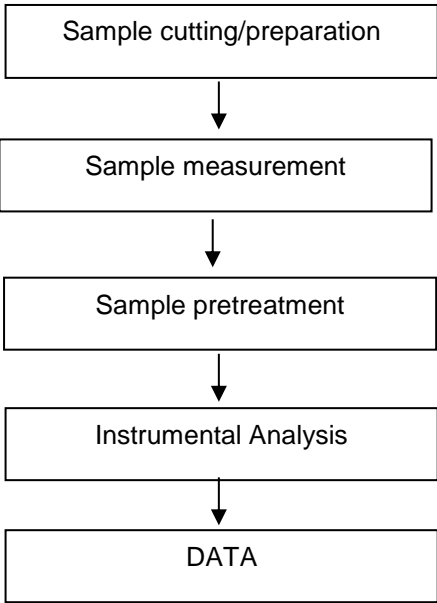

Testing Flow Chart





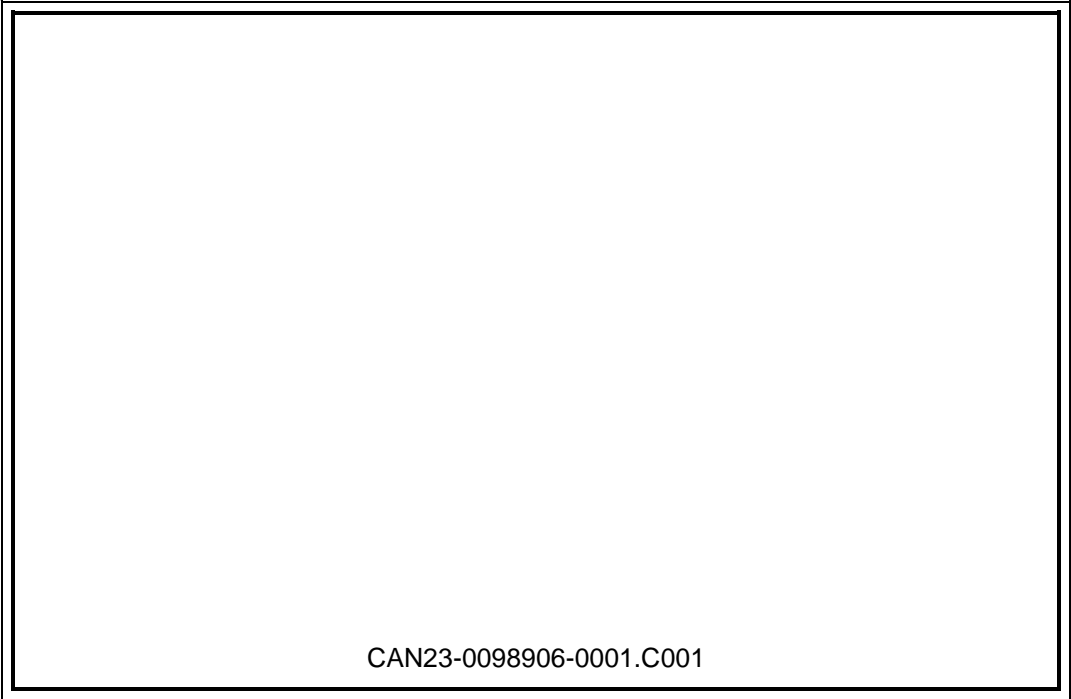
